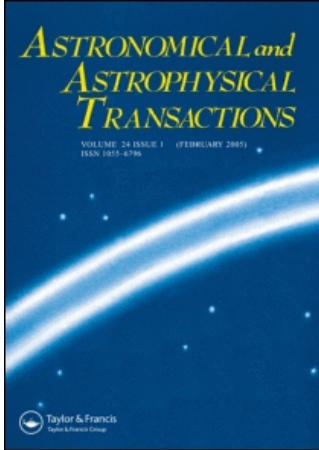

In this paper by Guseinov *et al.* ((2004) *Astron. Astrophys. Trans.* **23**, 385–394), there were several typographical and other errors.

On page 385, on the first line of the abstract, “The origin of some of the single pulsars. . .” should be read as “The origin of some of the single pulsars. . .”.

On page 391, line 3, “From these figures. . . are a slightly. . .” should be read as “From these figures. . . are slightly. . .”.
